- All contestants must provide copy of birth certificate.

- On-site registration will be Thursday, August 26, 2021 at the Grayson Co. fairgrounds pavilion from 6-7 p.m. (c.s.t) but not required. Forms will also be accepted day of the pageant and contestants must be registered between 3-4 pm CST.

## **Interviews:**

- Interviews will be held at the Grayson County Fairgrounds Women's building by gate 1 at 4 pm CST.

## **Attire:**

- Contestants will wear solid black colored t-shirt , khaki shorts, and choice of shoes for interview and introduction competition.
- Your choice of full-length pageant dress for evening gown competition.

## **Awards:**

- There will be a Winner, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> Runner-Up chosen in this event.

## **Rules and Regulations:**

- Contestant must be **13 years of age by October 31, 2021, and cannot be 16 on or before October 31, 2021.**
- Contestant must be single, never married or annulled, and never had any children or with child.
- A contestant can only represent one county fair they win first during the pageant calendar year.
- The Grayson Co. Fair Board and pageant committee reserves the right to revoke the title, under any circumstance, and cannot fulfill their duties/obligations. They will make the final decisions as necessary representing the Grayson County Fair pageant system during her reign.
- Rules from the KY Associations of Fair & Horse Shows apply to pageant participants.
- **Due to limited space, only 1 female person per contestant permitted in the dressing room!**
- The score sheets will be tallied by an accounting firm. No score sheets will be given to the contestants. All judges' decisions are final.
- The winner will represent the Grayson County Fair in the KY State Miss Teen Fair Pageant in Louisville, October, 2021.
