- All mailed entry forms must be postmarked by Friday, August 9, 2019.
- On-site registration will be Thursday, August 15, 2019 at the Grayson Co. fairgrounds pavilion from 6-7 p.m. (c.s.t) for local residents.

## **Attire:**

- Contestants will appear and be judged as a couple, but they do not have to dress as a couple.
- Contestants must wear “age appropriate attire” of your choice.

## **Awards:**

- There will be a Winner, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> runner-up chosen in this event.

## **Rules and Regulations:**

- Contestant must be must have reached their 5<sup>th</sup> birthday by June 30, 2019, and shall not have reached their 8<sup>th</sup> birthday by June 30, 2020.
- The winning couple will represent the Grayson County Fair in the KY State Little Miss/Mr. Fair Pageant, August 2020, in Louisville. For any reason the winner can't attend, the first runner-up will represent the fair.
- The winning couple will be required to attend the 2020 Miss Grayson County fair pageant as attendees for the event.
- A contestant can only represent one county fair they win first during the pageant calendar year.
- The Grayson Co. Fair Board and pageant committee reserves the right to revoke the title, under any circumstance, and cannot fulfill their duties/obligations. They will make the final decisions as necessary representing the Grayson County Fair pageant system during their reign.
- Rules from the KY Associations of Fair & Horse Shows apply to pageant participants.
- All judges' decisions are final.
