## **Entry Fee/Forms:**

- \$60.00 Non-Refundable and NO personal checks accepted (does not include gate admission – separate at the gate).
- All contestants must provide copy of birth certificate.

- On-site registration will be Thursday, August 25, 2022 at the Grayson Co. fairgrounds pavilion from 6-7 p.m. (c.s.t) but not a requirement. Forms will also be accepted day of the pageant and contestants must be registered between 4-5 pm CST @ Ronald H. Hudson Firehouse, 1303 Brandenburg Road, Leitchfield.

## **Interviews:**

- Interviews will be held at Ronald H. Hudson Firehouse immediately following Miss Teen Interviews.
- Contestants MUST be dressed and ready for interviews upon arrival. No curling irons/flat irons or hair products permitted inside building.

## **Attire:**

- Contestants will wear choice of interview outfit.
- One-piece pageant swimsuit for introduction AND swimsuit competition.
- Your choice of full-length pageant dress for evening gown competition.

## **Awards:**

- There will be a Winner, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> Runner-Up chosen in this event.
- Miss Grayson County Fair will represent at the Miss Kentucky County Fair Pageant in Louisville, January 2022.

## **Rules and Regulations:**

- Contestant must be **16 years of age by October 31, 2022, and cannot be 22 on or before October 31, 2022.**
- Contestant must be single, never married or annulled, and never had any children or with child.
- A contestant can only represent one county fair they win first during the pageant calendar year.
- The Grayson Co. Fair Board and pageant committee reserves the right to revoke the title, under any circumstance, and cannot fulfill their duties/obligations. They will make the final decisions as necessary representing the Grayson County Fair pageant system during her reign.
- Rules from the KY Associations of Fair & Horse Shows apply to pageant participants.
- **Due to limited space, only 1 female person per contestant permitted in the dressing room!**
- The score sheets will be tallied by an accounting firm. No score sheets will be given to the contestants. All judges' decisions are final.
